ORDER

As per the Government Order read 1st above, Government introduced Electronic Ledger Account Monitoring System (e-LAMS) to prevent hasty and imprudent expenditure at the fag end of the financial year. Thereafter detailed operational guidelines were also issued for the release and utilisation of the amount posted in e-LAMS vide G.O read 2nd above. As per G.O read 10th above, e-LAMS was extended to the financial year 2019-20 also.

Government are now pleased to extend the scheme for the current financial year (2020-21) also. All the guidelines issued so far will be applied during this year also. Apart from the above, the following additional guidelines are issued for strict compliance by all concerned.

- i. Under no circumstance the amount posted in the e-LAMS will be released after 30th September of the subsequent financial year.
- ii. All proposals requiring the posting of the amount under e-LAMS shall be submitted to the Finance Department well in advance, before 28.03.2021.
- iii. The resumption proposal, including the fund required under e-LAMS shall be submitted on or before 31.03.2021.


