Since the contract with the firm will expire on 21.10.2021, Director of Treasuries vide letter read 4th above has requested to accord administrative sanction for procuring Facility Management Service for Treasury Department for a further period of three years through e-Tender.

Government have examined the matter in detail and are pleased to accord sanction for procuring Facility Management Service for Treasury Department for a further period of three years through e-Tender by debiting the expenditure from the budget head 2054-00-095-99-19 (PV)-M&E. The Director of Treasuries is also directed to confirm the list of other IT equipments to be added under the purview of FMS.
