## **ORDER**

In the Government order read above Government have ordered that no payment of pension contribution to Government will be effected in respect of Government Servants transferred on deputation to institutions without any source of income to meet salary expenditure except grant-in-aid released by the State Government.

In view of the orders above, Government are pleased to incorporate Government Decision No.2 below the existing Government Decision which will be numbered as 1, under Rule 146 Part I Kerala Service Rules, with effect from 16.10.2012.

## Government Decision No: 2/2016

No payment of pension contribution will be effected in respect of officers transferred on deputation to institutions, where expenditure on salary is met exclusively from the grant-in-aid released by the State Government, for want of any other source of income to meet the expenditure.
