ORDER

As per the Government orders read as 1st & 2nd above, National Pension System (NPS) has been implemented in the State for all employees appointed in the services of State Government and PSUs on or after 01.04.2013 for whom provisions in Part III of Kerala Service Rules would have been applicable otherwise. Several requests have been received by Government, seeking to retain those employees who have been appointed into the service on or before 31.03.2013, but granted extension of joining time, beyond 31.03.2013 also under the Kerala Service Rules Part III Pension Scheme.


