**ORDER**

National Pension System (NPS) has been implemented in the State for All India Service Officers who are recruited to Kerala Cadre on or after 01.01.2004 and for State Government employees who are appointed on or after 01.04.2013 vide Government Orders read 1<sup>st</sup> and 2<sup>nd</sup> above. Consequent on implementation of the system, Government have established a NPS Cell in Finance Department under the overall supervision of State Nodal Officer (SNO) of NPS for proper monitoring and co-ordination of transactions in respect of NPS in the State. As per Government Order read 3<sup>rd</sup> above, a post of Head Accountant and two posts of Accountants with person from Treasury Department were deployed to the newly constituted Cell for a period of six months subject to conditions specified therein. The period of deployment of personnel from the Treasury Department will expire by October 2014.

2. Execution of NPS in the State including its implementation in institutions like State Autonomous Bodies, Local Self Government Institutions, etc., is at a crucial stage. Moreover Government feels that the NPS Cell has a pivotal role in the time bound and prompt implementation of the system. In the circumstances, Government are pleased to accord sanction for the extension of deployment of two posts of Accountants with person from Treasury Department for a further period of three months subject to other conditions mentioned in the Government Order read 3<sup>rd</sup> above.
