**ORDER**

As per para 2(viii) of Government Order read 1<sup>st</sup> above, Government had implemented National Pension System (NPS), with effect from 01.04.2013, in all Public Sector Undertakings (PSUs) where pensionary benefits envisaged under PART III Kerala Service Rules are granted. Detailed guidelines for the implementation of NPS in PSUs/Autonomous Bodies/Boards/Universities and Local Self Government Institutions (LSGIs) were issued vide Government Orders read 4<sup>th</sup> and 5<sup>th</sup> above. But majority of these institutions have not yet completed the procedures mandatory for the execution of the System. As a result there is no provision, at present, to deduct NPS contribution in respect of employees covered under NPS deputed to State Government Departments from the above establishments.

2. Detailed instructions for the implementation of NPS for State Government employees have been issued in Government order and Circular cited second and third above and the Scheme is in operation at State Service.

3. In these circumstances, Government are pleased to order that the present procedures followed in the case of State Government employees shall be applicable for NPS covered employees deputed to State Service from PSUs/State

Autonomous Bodies/Boards/Universities/Local Self Government Institutions/Central Autonomous Bodies/Central Government/ other State Governments with respect to registration of subscribers, deduction of employee contribution, providing equal matching employer contribution and contribution/data upload.


