ORDER

1. Government of India had introduced National Pension System to the Central Government employees w.e.f 01.01.2004 vide notification referred as 1<sup>st</sup> paper above. As per the Government Order read 2<sup>nd</sup> Paper above, this scheme has been made applicable to the state employees who are appointed into the service on or after 01.04.2013. Further, State Government Servants/ Autonomous Body employees/Aided Institution employees were also allowed mobility to continue in KSR Part III Pension scheme vide Government Order read 3<sup>rd</sup> and 4<sup>th</sup> paper above. Several requests to retain those employees, who have been appointed in Central Government Service and later joined/joining in the State Government service in KSR Part III Pension scheme, have also been received in Government.

2. Government have examined the matter in detail and are pleased to order that the Central Government employees who are governed by the CCS(Pension)Rules 1972 later joined/joining the State Government service on or after 01.04.2013 would be allowed mobility to continue in KSR Part III Pension Scheme subject to the condition that there

shall not be any break in between the two services. For this, the employees would be allowed to exercise option to be governed by KSR Part III Pension Scheme within three months of joining the new establishment in the form appended to this Government Order to the appointing authority concerned. Those who have already joined the new service in state government shall submit the option form within three months from the date of this order. The appointing authority shall issue orders in this regard after verifying the prior service of the incumbent.


