**ORDER**

In the Government Order read as 1<sup>st</sup> paper above, Government have issued guidelines for the implementation of the scheme LAC-ADS for MLAs wherein it is stated that Agencies while taking up works under the scheme are not eligible for any supervision, centage charges, administrative charges etc. As per the Government Order read as 2<sup>nd</sup> and 3<sup>rd</sup> paper above the Centage/Consultancy charges are payable to Government accredited agencies for carrying out regular works on behalf of Government Departments.

2. Government, after having examined the matter in detail are pleased to allow the Centage/Consultancy charges at the rates prescribed in the Government Orders as 2<sup>nd</sup> and 3<sup>rd</sup> paper read above for the works executed under LAC ADS. The Contractor's profit, tender excess, over head charges etc. will not be payable. This order will take effect from the date of issue of this order.

3. The Government Order read as 1<sup>st</sup> paper above will stand modified to this extent.
