### ORDER

Government, in the Order read 1<sup>st</sup> above have enlisted Uralungal Labour Contract Co-Operative Society as a Government accredited agency. As per the Government Orders read 2<sup>nd</sup> to 4<sup>th</sup> above, the guidelines for the maximum value of single work and the total cost of works at hand for the accredited agencies have been revised. Now, Uralungal Labour Contract Co-Operative Society , as per their request read 5<sup>th</sup> above, has requested to enhance these monetary ceilings in their case as the ceilings curb them from taking up more public works for execution despite they are in under utilization of their technical competence and man and machinery.

2) Government have examined the matter in detail. The Uralungal Labour Contract Co-operative Society is one of the bigger, older labour contract co-operative societies in the State. The society has proved competence with plant and machinery for the execution of

public works and has been providing employment for a good number of labourers with better wages. Moreover, there is active demand from Government departments to entrust their works with the society for execution. In consideration of all these points, Government are pleased to enhance the maximum value of single work and the total value of works to be taken up newly in a financial year in respect of the Uralungal Labour Contract Co-operative Society as Rs. 150 Crore and as Rs. 500 Crore respectively.
