ORDER

As per the Government Order read as 1st above, orders have been issued revising the pay and allowances of State Government employees and teachers w.e.f. 01.07.2009 wherein Uniform Allowance at varying rates have been sanctioned to various categories of employees and it was ordered, inter alia, that the categories of employees which were not included in the schedule of Uniform Allowance, but are required to wear uniform are eligible for Uniform Allowance @ Rs.1600 per annum. As per the Government Order read as 2nd above, orders have been issued further revising pay and allowances of employees with effect from 01.07.2014, wherein the payment of various allowances has been rationalised on condition that the allowances which are not specifically included in the respective schedules of allowances will be treated as withdrawn. The Commissioner of Land Revenue vide his letter read above has reported that the categories of Sergeant, Duffedar, Chowkidar, Lift Operator, Gardener and Sanitation Worker of his department were not included in the Schedule of Uniform Allowance, but were paid Uniform Allowance @ Rs.1600 per annum prior to the implementation of 10th Pay Revision

by virtue of the provision in the 9th Pay Revision Order. The Commissioner has reported that the above mentioned categories are required to wear uniform invariably during their duty time, but they could not be paid Uniform Allowance because of the condition provided in the 10th Pay Revision Order. Hence he has requested to restore Uniform Allowance to the categories of Sergeant, Duffedar, Chowkidar, Lift Operator, Gardener and Sanitation Worker.

2. Government have examined the matter in detail and are pleased to sanction Uniform Allowance @ Rs.2400 per annum to the posts of Sergeant, Duffedar, Chowkidar, Lift Operator, Gardener and Sanitation Worker in Land Revenue Department.


3. This order will take effect from 01.04.2016.
