ORDER

As per the Government Order read as 1st above, orders have been issued revising pay and allowances of State Government Employees and Teachers w.e.f 01.07.2009, wherein Uniform Allowance at varying rates has been sanctioned to various categories of employees and it was ordered, inter alia, that the categories of employees which were not included in the schedule of Uniform Allowance, but are required to wear uniform, are eligible for Uniform Allowance @ Rs.1600 per annum. As per the Government Order read as 2nd above, orders have been issued further revising pay and allowances of employees with effect from 01.07.2014, wherein the payment of various allowances has been

rationalized on condition that the allowances which are not specifically included in the respective schedules of allowances will be treated as withdrawn. The Chief Engineer, Public Works Department vide his letter read above has reported that the category of Ferryman who is engaged in ferrying passengers were paid Uniform Allowance @ Rs.1600 per annum by virtue of the general enabling provision in the Government Order read as 1st above prior to the implementation of 10th Pay Revision. He has reported that Ferrymen are required to wear uniform during duty time but now they could not be paid Uniform Allowance since the category is not specifically included in the Schedule of Uniform allowance of Public Works Department. Therefore he has requested to restore them Uniform Allowance.

2. Government have examined the matter in detail and are pleased to sanction Uniform Allowance @ Rs.2400 per annum to Ferryman of Public Works Department who are engaged in ferrying passengers by country boats.

3. This order will take effect from 01.10.2017.
