

Finance Department - Pay Revision 2014 - Special Pay Admissible to Staff Working in Parambikulam Aliyar Project (JWR Division), Mullaperiyar Project and Siruvani Drinking Water Project - Orders Issued.

ORDER

As per Government Order read as 2nd above, Government have sanctioned Special Pay @ 8% of Basic pay as incentive to the staff working under three interstate projects ie, Parambikulam Aliyar Project (JWR Division(IDRB) Palakkad), Mullaperiyar Dam Area(Minor Irrigation Division, Idukki, Kattappana) and Siruvani Project Sub Division, Section Offices and Executive Engineer(KPIP Division, Kanjirapuzha) on condition that no Dearness Allowance will be allowable for the Basic pay. In the letter read above, the Accountant General has sought clarification on the rates and date of effect of incentive to be sanctioned to the staff working under the interstate projects mentioned above, in the wake of implementation of the 10th Pay Revision.

2. Government have examined the matter in detail and are pleased to order that a hike of 15% will be allowed on the existing Special Pay which is @ 8% of basic pay in the pre-revised scale sanctioned to the staff working under the interstate projects viz, Parambikulam Aliyar Project (JWR Division(IDRB) Palakkad), Mullaperiyar Dam Area(Minor Irrigation Division, Idukki, Kattappana) and Siruvani Project Sub Division, Section Offices and Executive Engineer(KPIP Division, Kanjirapuzha) with effect from 01.04.2018 on condition that no Dearness Allowance will be admissible on the Special Pay.

Illustration:

An officer with a pre-revised basic pay of Rs.36140 will be granted Special Pay as follows:

- (i) Existing Special Pay @ 8% of Basic Pay: Rs.2891
- (ii) 15% hike on the existing special pay : Rs.434

Revised Special pay w.e.f. 1.4.2018 :(i) + (ii) : Rs.3325
