**ORDER**

Smt. Mareenamma Sebastain, HSS Teacher. retired has filed WP(C)No.24213/2017 before the Hon'ble High Court of Kerala to reckon the temporary aided school service for pensionary benefits.

2. Smt. Mareenamma Sebastain retired as HSS Teacher (Malayalam) at St. Joseph's GHSS Changanassery, Kotayam on 31.03.2016. The incumbent entered continuous service as UPSA at St. Mary's High School Chambakulam w.e.f 11.06.1990. Before such entry in continuous service, she had 7 spells of temporary aided school service during the period from 10.01.1986 to 23.01.1990 ( 1 year, 6 months and 8 days)

3. Considering the common judgment dated 14.08.2017 in WP(C) No.30167/16, the Hon'ble High Court of Kerala has ordered the respondents to refix the pensionary benefits due to the petitioner accordingly and disburse the same within a period of four months vide judgment read 1 st above.

4. Government have examined the matter in detail and in view of the Government order read 3<sup>rd</sup> and 4<sup>th</sup> above are pleased to reckon the broken spells of service rendered by the applicant from 10.01.1986 to 23.01.1990 (1 year, 6 months and 8 days) as qualifying service along with regular service for pensionary benefits.

5. Thus the order of the Hon'ble Kerala High Court stands complied with.
