## ORDER

As per Government Order read as 3<sup>rd</sup> paper above, Government accorded Administrative Sanction for executing the work "Implementation of Smart Class Room in 26 schools in Kalliassery LAC" at an estimated cost of Rs. 35,83,766/-. The work has been awarded to M/s. Kerala Small Industries Development Corporation Ltd (SIDCO), an Accredited Agency.

The Director of Vocational Higher Secondary Education, vide letter read at 4<sup>th</sup> paper above has forwarded payment request from SIDCO for an amount of Rs.5,01,065/- towards the installation charges of Smart Class Rooms in four Vocational Higher Secondary Schools in Kalliassery LAC. The DVHSE has requested to release the amount to SIDCO.

As per the Government Order read as 2<sup>nd</sup> paper above, payment of bills for works executed through Accredited Agencies shall be effected by debiting the expenditure to the Head of Account "5475-00-800-91- Projects under LAC-ADS (NP)". It has been further ordered that AD/HoD shall draw and disburse the allotted funds to the Accredited Agency concerned on the strength of allotment order issued from Finance Department. As per the Circular read as 1<sup>st</sup> paper above, in the case of LAC-ADS works executed through Accredited Agencies, release of funds shall be effected in instalments depending upon the utilisation of advanced amount.

Government have examined the matter in detail and are pleased to permit the Senior Administrative Officer, Directorate of Vocational Higher Secondary Education, Thiruvananthapuram to draw and disburse an amount of Rs.5,01,065/- (Rupees Five Lakh One Thousand and Sixty Five only), being the part payment towards the work executed by SIDCO from the District Treasury,

Thiruvananthapuram by debiting the expenditure under the Head of Account "5475-00-800-91-Projects under LAC-ADS (NP)", subject to the condition that the DVHSE should ensure the correctness and completion of works of the proposed amount towards the installation of smart class rooms in various schools is as per the Government Order read as 3rd above before effecting payment and by strictly observing the guidelines issued in the Government Order. The Administrative Department shall also ensure before effecting payment, the correctness of delivery and that the equipments are received in good conditions as per the specifications in the original estimate. The District Treasury Officer, Thiruvananthapuram shall honour the bill when presented by the Senior Administrative Officer, Directorate of Vocational Higher Secondary Education, Thiruvananthapuram who is the Drawing and Disbursing Officer.
