ORDER

Sri.Rajasekharan C has filed WP(C)No.35788/17 before the Hon'ble High Court of Kerala to consider his service as Peon at Munsiff Court Varkala for minimum pension on the basis of G.O(P) No.897/96/Fin dated 08.11.1996. He was provisionally appointed as Peon under rule 9(a) (i) of Part II of KS & SSRs about 4.5 years from 22.12.2008 to 24.06.2013. He submits that he is differently abled (physically handicapped) person with 40% disability and hence claims the benefits of the G O read above. As per judgment read above, the Hon'ble High Court of Kerala has ordered the respondents to consider and pass orders on the said representation of Sri. Rajasekharan C within a period of two months.

2. As per G.O(P) No.897/96/Fin dated 08.11.1996 minimum pension is granted to all differently abled regular Government Employees with 40% permanent/partial disability having a minimum period of 3 years of qualifying service.

3. Based on the judgement, Government conducted a hearing on 15.03.2018 and the incumbent, attended the hearing. At the time of hearing he had requested to consider his temporary service as peon at Munsiff Court Varkala for pensionary benefits.

4. As Sri. Rajasekharan was provisionally appointed as Peon through Employment exchange and as Government has not regularised his appointment, he is not eligible for pensionary benefits contemplated in G.O(P) No.897/96/Fin dated 08.11.1996. In this circumstance the plea of Sri. Rajasekharan cannot be considered and hence rejected.

5. Thus the order of the Hon'ble Kerala High Court stands complied with.
