ORDER

As per the Government Order read above, orders were issued explaining the procedure for realization of backlog contributions towards National Pension System in respect of All India Service Officers recruited to Kerala Cadre. In clause (i) of para 2 of the Government Order, it was ordered that the initial training period will not be reckoned for computation of backlog contributions. Several representations from All India Service Officers were received in Government requesting to reckon their initial training period for computation of backlog contributions.

2. Government have examined the matter in detail and are pleased to modify clause (i) of para 2 of the Government Order read above as follows:

“In the case of All India Service Officers whose pay and allowances for the training period is being reimbursed by the State Government, their initial training period will be reckoned for computation of backlog contributions”.

3. The Government Order read above stands modified to the above extent.
