**ORDER**

Vide Government Order read 1<sup>st</sup> above, Government have resumed an amount of Rs. 4,92,32,841/- from the STSB Account No. 14/61 of Kerala Land Information Mission. As per the guidelines issued in the circular read above, the resumed amount has to be re-allocated by providing additionally under the head of account “2075-00-800-72-02” in the current financial year based on actual requirement, since it was not drawn from the consolidated fund of the state. Now vide letter read above, the Additional Mission Director, Kerala Land Information Mission, Thiruvananthapuram has requested to allocate the amount resumed from the STSB account of the Mission for meeting various requirements.

2. Government have examined the matter in detail and are pleased to accord sanction for release of Rs. 4,92,32,841/- (Rupees four crore ninety two lakhs thirty two thousand eight hundred and forty one only) from the head of account

“2075-00-800-72-02 (PV)”. The Deputy Secretary, Finance (Accounts) Department will take necessary steps to draw and transfer credit this amount from the Head of Account “2075-00-800-72-02 (PV)” to the concerned Treasury Savings Bank Account of the Mission as specified below.
