ORDER

Vide Government Order read 1st above, Government have resumed an amount of Rs. 2,12,99,000/- from the STSB Account No. STSB A/C no. 701041400000072 of Kerala Police for the purpose of Coastal Security Scheme . As per the guidelines issued in the circular read above, the resumed amount has to be re-allocated by providing additionally under the head of account “2075-00-800-72-02” in the current financial year based on actual requirement, since it was not drawn from the consolidated fund of the state. Now vide letter read above, the State Police Chief ,Kerala has requested to allocate the amount resumed from the STSB account for meeting the expenses of Coastal Security Scheme.

Government have examined the matter in detail and are pleased to accord sanction for release of Rs.2,12,99,000 /- (Rupees two crore twelve lakhs ninty nine thousand only) from the head of account “2075-00-800-72-02 (PV)”. The Deputy Secretary, Finance (Accounts) Department will take necessary steps to draw and transfer credit this amount from the Head of Account “2075-00-800-72-02 (PV)” to the concerned Treasury Savings Bank Account of the Mission as specified below.
