ORDER

As per the G.O read as 1st paper above, orders have been issued revising the pay and allowances of State Government Employees and Teachers, w.e.f 01.07.2009, wherein the posts of Ayurveda Therapist(HG) and Ayurveda Therapist under the schedule of Indian Systems of Medicine were in the ratio of 1:3. Later the 10th Pay Revision Commission recommended to revise the ratio between the posts of Ayurveda Therapist (HG) and Ayurveda Therapist as 1:2. But in the Government Order read as 2nd above, the ratio between Ayurveda Therapist and Ayurveda Therapist(HG) under the schedule of Indian Systems of Medicine has been entered as 1:2 instead of 2:1. Hence the Director, Indian Systems of Medicine vide his letter read above, has requested to correct it.

2. Government have examined the matter in detail and are pleased to substitute the footnote 'g' under the department schedule of Indian Systems of Medicine at page 235 of G.O read as 2nd above as follows:

'g':- Ratio between Ayurveda Therapist and Ayurveda Therapist(HG) will be 2:1.


3. This order will take effect from 01.04.2016.
