ORDER

As per the Government Order read as 1st above, Government have issued orders revising Pay and Allowances of State Government Employees and Teachers w.e.f. 01.07.2014, wherein it was ordered that the State Government Employees working in New Delhi and other States will be eligible for House Rent Allowance at Government of India rate as applicable at those places. Also as per Government Order read as 2nd above, it was further clarified that the State Government Employees working in New Delhi and other States are eligible for the existing rate of House Rent Allowance last drawn on the basis of

the pre-revised scale till the implementation of the 7th Central Pay Revision. The Manager, Department of Tourism, Kerala House, Kanniyakumari, in his letter read as 3rd above has sought clarification on the admissibility of revised House Rent Allowance to State Government Employees working at Kerala House, Kanniyakumar based on the recommendation of the Seventh Central Pay Commission.

2)Government have examined the matter in detail and are pleased to order that the State Government Employees working at Kerala House, Kanniyakumari will be eligible for House Rent Allowance @ 8% of Basic Pay w.e.f 01.07.2017 and the rate of House Rent Allowance will be revised to 9% of Basic Pay when Dearness Allowance of Central Government Employees crosses 25% and to 10% of Basic Pay when the Dearness Allowances crosses 50%.
