ORDER

Smt. Syamalakumari.M, U.P. School Assistant (Rtd) has filed WP(C)No.4454/2018 before the Hon'ble High Court of Kerala to reckon the broken service for pensionary benefits.

- 2) Smt. Syamalakumari.M retired from service as U.P. School Assistant from an Aided U.P. School, Vallikunnu, Malappuram District on 31.03.2016. The incumbent entered continuous service on 12.06.1987. Before such entry in continuous service, she had broken service from 01.09.1986 to 31.03.1987 (7 months).
- 3) Vide judgement read above, the Hon'ble High Court of Kerala has ordered the respondents to refix the pensionary benefits of the petitioner, after reckoning the provisional service and to grant her all consequential benefits within a period of three months.
- 4) Government have examined the matter in detail and in view of the Government Orders read above are pleased to reckon the broken period of service rendered by the applicant from 01.09.1986 to 31.03.1987 as qualifying service along with regular service for pensionary benefits.

5) Thus the order of the Hon'ble High Court of Kerala stands complied with.
