**ORDER**

Regular recruitment to the post of Assistant and direct recruitment to the post of Assistant Manager in Kerala Financial Corporation are vested with the Kerala Public Service Commission. The qualifications fixed for these posts are detailed below:

Assistant : B.A(Economics) or B.Com with Diploma in Computer Application (DCA) from an institution approved by Government of Kerala/Government of India.

Assistant Manager : CA/ICWA/MBA (Finance) OR First Class PG Degree in Economics or Commerce with Government recognized Degree/Diploma in Computer Science/Computer Application and minimum five years' experience in Industrial Financing field as desirable qualification.

2. The Managing Director of Kerala Financial Corporation, vide letter read as 2nd paper above, informed that the Board of Directors of Corporation held on 24/03/2017 resolved to revise the essential qualifications for the posts mentioned above and the Managing Director has proposed to revise the Qualifications as per letters read as 2<sup>nd</sup>, 3<sup>rd</sup> and 5<sup>th</sup> papers above. The proposal for revision of qualifications for the posts of Assistant and Assistant Manager was approved by Kerala Public Service Commission with certain modifications, vide letter read as 4<sup>th</sup> paper above.

3. Government have examined the matter in detail and are pleased to revise the qualifications for the posts of Assistant and Assistant Manager of Kerala Financial Corporation to be recruited through Kerala Public Service Commission to the following extent:

SL. No.	Name of Post	Qualifications
1.	Assistant	B.Com from a recognised University with 60% or above marks in aggregate.
2.	Assistant Manager	(i) Graduation with First Class from a UGC recognised University (ii) CA(Intermediate) or ICWA (Intermediate) Note:- First Class Degree means 'with 60% or above marks in aggregate'.

4. Necessary amendment in the special rules will be issued later.
