ORDER

The Accountant General (A&E), Kerala in his letter read above has admitted the following pensionary benefits to Sri. P.P.Chериан Kunju IFS ,Divisional Forest Officer who retired from service on superannuation on 31/03/2016 after withholding the proposed liability of Rs.37,326/- from his DCRG.

Vide 2nd read G.O,only provisional pension amounting Rs. 20,550/- had been sanctioned as there had a vigilance case and disciplinary action against the incumbent. But now as per the Remarks by the Receiving Authority vide 3rd read above Government have issued Orders for finalizing the disciplinary proceedings initiated against Sri.P.P.Chериан Kunju IFS (Rtd) by

withholding an amount of Rs. 37,326/- (Rs. Thirty Seven thousand Three hundred and Twenty Six Only) ie, the proportionate liability towards the loss sustained to Government from h.s DCRG. Accordingly, the Government are pleased to accord sanction for Payment of Final Pensionary benefits as detailed below to Sri.P.P.Chериан Kunju IFS (Rtd).

Commutated Value of Pension	Rs. 22,10,414/- (Rupees Twenty two Lakhs Ten thousand Four hundred and Fourteen only)

The Pension is payable with effect from 01.04.2016 after adjusting the earlier disbursement of provisional pension.

This sanction is subject to AIS (DCRB) rules.
