ORDER

As per the G.O. 1st read above, sanction was accorded to open a current Bank Account in the designation of the Controller, Kerala House, New Delhi with State Bank Of Travancore (State Bank of India) Parliament Street Branch, New Delhi for facilitating online transactions to the guests and for Kerala House administration for period of one year (up to 11.02.2018) or till treasury bill system and SPARK are fully operational in Kerala House, whichever is earlier. Later, as per G.O. read as 2nd paper above, Government have accorded sanction to operate the said Current Bank Account for a further period of six months (ie, up to 11.06.2018), on condition that no further extension will be allowed. Now the Controller, Kerala House, New Delhi has reported that the implementation process of SPARK is ongoing in Kerala House and it will take few more months for the implementation of the SPARK. Hence, vide letter read 3rd above, it is requested to grant permission to operate the above Current Bank Account for one more year for the purpose of online financial transactions.

2. Government have examined the matter in detail and are pleased to accord sanction to operate the Current Bank Account in the designation of the Controller, Kerala House New Delhi till 31.03.2019 on condition that no further extension will be allowed.
