NOTIFICATION

S.R.O. No. 434/2006—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with Section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules, namely:—

RULES

- Short title and commencement.—(1) These rules may be called the Kerala Service (Amendment) Rules, 2005.
- (2) It shall be deemed to have come into force on the dates indicated thereunder.
- Amendment to the Rules.—In clause (iii) of sub-rule (a) of rule 67 of Kerala Service Rules, Part II.
 - (i) in sub-clause (a), the letters and figures "Rs. 3000" shall be deemed to have been substituted with the letters and figures "Rs. 2500" with effect from 1st July, 1988 and with letters and figures "Rs. 3000" with effect from 1st September, 1995.
 - (ii) in sub-clause (b), the letters and figures "Rs. 2500" and "Rs. 3000" shall be deemed to have been substituted with the letters and figures "Rs. 1800" and "Rs. 2500" with effect from 1st July, 1988 and with letters and figures "Rs. 2500" and "Rs. 3000" with effect from 1st September, 1995.

Explanatory Note

In the Notification issued under G. O. (P) No. 391/2002/Fin. dated the 19th June, 2002 and published as S. R. O.
