ORDER

The Government Primary School Headmasters were empowered to sanction Temporary Advance/Non -refundable Withdrawal of the Staff of Primary Schools subject to a limit of Rs. 50,000/-. But Government have issued orders in the Government Orders read as 1st and 2nd papers above restricting the power to the lowest Gazetted Officer/Drawing & Disbursing Officer having a scale of pay Rs.10,790-18,000. So the Primary School Head Masters who are neither Gazetted nor having the above scale of pay ceased to be the sanctioning authorities of GPF. Since then the Kerala Primary School Head Masters have been representing to Government to restore the sanctioning power.

Government after detailed examination are pleased to order that, Kerala Government Primary School Headmasters will be the sanctioning authority of TA/NRA from GPF of the Primary School Staff with the upper monetary limit of Rs.50,000/- in modification of orders issued in Government Order read as 2nd paper above.


