Abstract

Pension – Revision of pension and family pension to those coming under UGC / AICTE / Medical Education Schemes and retired prior to 1.1.1996 based on the pay scales from 1.1.1996 – Orders issued.

ORDER

In the Government Order read as 1st paper above, Government have revised the pension and other related benefits of State Government pensioners and family pensioners consequent on the revision of scale of pay of State Government. As per the Government Order read as 2nd paper above, Government revised the pension provisionally in respect of those who come under UGC / AICTE / Medical Education Schemes retired prior to 1.7.2004.

(2) Requests have been received from the persons who retired prior to 1.1.1996 to allow them the benefits as mentioned in the Government Order read 1st above based on the 1996 pay scales as in the Government Order 3rd above.

(3) Government, after having examined the matter in consultation with Accountant General (A&E) and are pleased to revise the pension / family pension to those coming under UGC / AICTE / Medical Education Scheme and retired prior to 1.1.1996 as follows :

Revision of pension in respect of those who retired / expired prior to 1.1.1996.

- 3.1 Date of effect :- Pension in respect of those retired / expired prior to 1.1.1996 shall be revised from 1.4.2005, in accordance with the principles laid down herein. During the period from 1.1.1996 to 31.3.2005, they shall continue to get pension at the same rate as prior to revision.
- 3.2 Revised Basic Pension :- To arrive at the revised Basic Pension, calculated value, comprising the following, shall be first determined :
- (i) Existing Basic Pension ;
 - (ii) Fitment Benefit of 6% of existing basic pension (ie., of (i) above). If it involves fraction of a rupee, it shall be rounded off to the next higher rupee.
 - (iii) 59% of existing Basic Pension (ie., of (i) above) as rounded off to the next higher rupee.
- 3.3 If the total of (i) to (iii) above (called calculated value) is less than 50% of the minimum of the corresponding revised scale of the post from which the pensioner retired, then, in the case of pensioners having qualifying service of 30 years and above, the pension shall be stepped up to 50% of the minimum of the revised scale. In the case of others with qualifying service of less than 30 years, pension proportionate to the qualifying service as indicated in schedule 1 alone will be admissible.
- 3.4 Subject to the provisions of paragraph 3.6 below, if the calculated value is greater than 50% of the minimum of the corresponding revised scale of the post from which the pensioner retired, the basic pension, based on qualifying service, shall be fixed at such calculated value if it is a stage in Schedule 1 or at the immediate next stage in Schedule 1 if the calculated value is not a stage in the Schedule (stages are detailed in schedule 1). Pensioners with lesser qualifying service are eligible only for proportionate pension.
- 3.5 Proportionate pension means the maximum pension admissible for any particular stage multiplied by the qualifying service factor (QS/30). The detailed table for determining proportionate pension is given in schedule 1.
- 3.6 While fixing the revised basic pension as indicated in paragraph 3.4 above, a minimum benefit of Rs.200/- over the basic pension plus merged DR at 59% shall be ensured. If, in any case, the pension fixed at a stage in the schedule does not ensure a benefit of Rs.200/-, the shortage may be added to the pension already fixed and this will be the final revised basic pension, even if it is not a stage in schedule 1.

3.7 If, in any case, the amount so arrived at is less than the minimum pension (Rs.2400), it shall be enhanced to the level of the revised minimum pension.

(4) The revision of family pension in respect of those who retired / expired while in service prior to 1.1.1996.

4.1 Family pension in respect of those who retired / expired while in service prior to 1.1.1996 shall be revised from 1.4.2005, in accordance with the principles laid down herein. During the period from 1.1.1996 to 31.3.2005, they shall continue to get family pension at the same rate as prior to revision.

4.2 To arrive at the revised family pension in respect of those who retired / died while in service prior to 1.1.1996, calculated value, comprising the following shall be first determined;

(i) Existing Basic Family Pension ;

(ii) Fitment benefit at 6% of the existing basic family pension (ie., of (i) above) ;

(iii) DR at 59% of the existing Basic Family Pension (ie., of (i) above).

4.3 The revision as above is applicable to both normal and higher rates of family pension.

4.4 In the case of normal family pension, if the total of items (i) to (iii) above is less than 30% of the minimum of the corresponding revised scale of the post from which the pensioner retired / died while in service, as indicated in Column 3 of Schedule 2, it shall be stepped up to that amount subject to a minimum of Rs.2400/-

4.5 If, in any case, the family pension arrived at as above does not ensure a benefit of Rs.200/- over the existing basic family pension plus merged DR at 59%, the shortage shall be added to the family pension already fixed and this will be the final revised family pension, even if it is not a stage in Schedule 2.

4.6 The Scale of Pay effective from 1.4.1990 and the corresponding revised Scale of Pay effective from 1.1.1996 is given in Schedule 3.

(5) The revision of pension / family pension as per these orders will have monetary effect with effect from 1.4.2005 and shall be applicable only to those who retired prior to 1.1.1996. Dearness Relief on the revised pension / family pension will be 8% as on 1.4.2005. Further increase in Dearness Relief with effect from 1.7.2005 will be as admissible to the State Government employees from time to time.

(6) Each pensioner / family pensioner who comes under the scheme of UGC / AICTE / Medical Education Schemes shall submit a written request in the form in Appendix 9 to revise their pension / family pension in accordance with these orders. In such cases, arrears of pension can also be paid in accordance with para 10 of Government Order read (i) above in respect of those who retired prior to 1.1.1996 and died on or after 1.4.2005.

(7) (i) Those who had retired prior to the introduction of the respective Schemes / opted out of the Schemes and enjoyed the benefits contemplated in G.O. (P) No. 180/2006/Fin, dated 18.4.2006 are not eligible for revision of pension as per these orders and (ii) the revised pension to be paid after adjusting the provisional pension already paid as per G.O (P) No. 81/2007/ Fin, dated 28.2.2007.

(8) The revision of pension and family pension as per this order in respect of those who are receiving the same from Treasuries (whether inside the State or outside) will be done by the Treasury / Sub Treasury Officer concerned. The revision in respect of those who receive pension through Banks will be done by the Bank Manager concerned.

(9) After the revision of pension / family pension, the Treasury Officer / Pension Disbursing Authority shall prepare a statement in the form given in Appendix 10 in duplicate and send one copy of the same to the Accountant General (A&E), Thiruvananthapuram, Kerala for verification and updation of the registers maintained by the Accountant General. In cases where the Pension Disbursing Authority is a nominated Public Sector Bank, the fixation statement shall be prepared in triplicate and one copy sent to the Accountant General and one copy attached to the scroll for payment of revised pension for the 1st time. The correctness of the fixation made by the Public Sector Bank will be checked by the District Treasury Officer concerned when the scroll is included in the Treasury accounts.

(10) Any doubts in the revision of pension / family pension may be clarified with the Accountant General's Office.
