ORDER

Ex-gratia Pension Scheme was introduced to those who retire from service on superannuation and are ineligible for statutory pension, as per the Government Order read as 1st paper above. Pension and other related benefits of State Government pensioners were revised as per Government Order 2nd cited. In para 11.2 of the above Government Order 2nd cited, it was specified that ex-gratia pension in respect of those who are retiring after 1-7-2004 will be revised separately.

2. Government after having examined the matter in detail, are pleased to revise the rates of ex-gratia pension for those retiring after 1-7-2004 as follows:-
