## ORDER

As per Government Order fourth read, a total prohibition was imposed on the use of Government vehicles for all kinds of non duty purposes. The relevant rules prescribed in the Government Order second read were also suspended. Subsequently, the prohibition was partially lifted and as per Government Order fifth read, certain senior level officers were allowed the use of Government vehicles for non duty purposes on payment basis. As the existing fare of Rs. 2.50 per K.M. for such journeys is too uneconomical now, Government Order that the rate be revised as Rs. 3 per K.M. effective from 1-3-2003.
