Sub:- Pay Revision-2009 - Directions issued.

Orders have been issued revising the pay and allowances of state government employees and teachers vide the Government Order read first and second above. The 9th Pay Revision Commission in its report has recommended new pay scales to certain categories of posts with multi level hikes instead of normal revision of the existing scales of pay. Government have examined the matter and rationalized it, limiting the hikes to two levels except for Medical Officers (Allopathy). In the case of recommendations with reference to improved/new ratio promotions to the posts having more than scale-to-scale revisions, such recommendations were not accepted.

For adhering to the above guidelines scrupulously, Government hereby issue the following directions, based on the Government Orders read above

- a) All Heads of Departments should ensure that the revised scales of pay included in the Schedule of Posts are as recommended by the 9th Pay Revision Commission and wherever hikes are above scale to scale revision, such hikes should not be above two-level (except for Medical Officers -Allopathy), wherever the 9th Pay Revision Commission recommended for more than two-level hikes. Similarly, no improved/new ratio promotions should be granted to those posts having a revision above scale-to-scale revisions. The Heads of Departments should ensure this before starting the work for fixation of pay in the revised scales.
- b) All Heads of Departments should report to Government whether any category of post except Medical Officer (Allopathy) is placed at a scale more than two level higher and whether any category of post has been given improved/new ratio promotion which has already been placed in scale above normal revision.

c) All the cases relating to (a) and (b) above should be brought to the notice of Government in Finance Department through the concerned Administrative Department.


