ORDER

1. Government have reintroduced House Building Advance Scheme to State Government Employees and Teachers as per Government Order read as 1st paper above .
2. As per Government Order read as 2<sup>nd</sup> above, 104 schools under the control of Panchayat/Municipality have been taken over by the Government and decided to regularise the service of the teaching/ non teaching staff working in these schools subject to the approval of Public Service Commission.
3. In the Government Order read as 3<sup>rd</sup> paper above, Government have fixed the criteria for seniority, promotion, grade and transfer of teaching / non teaching staff working in these schools with the approval of Public Service Commission. Therefore, the Administrative Department has proposed to extend House Building Advance Scheme to teaching / non teaching staff working in Panchayat / Municipality schools which have been taken over by Government treating them as State Government Employees and Teachers.
4. Government have examined the matter in detail and are pleased to extend House Building Advance Scheme to the teaching/ non teaching staff working in 104 Panchayat/Municipality schools which have been taken over by Government as per Government Order 2<sup>nd</sup> and 3<sup>rd</sup> cited, subject to the conditions stipulated in the Government Order read as 1<sup>st</sup> above, from the financial year 2015-16.
