**ORDER**

Government vide order 1st read above, issued general guidelines for executing public works through various accredited agencies. These guidelines were revised with effect from 1<sup>st</sup> August 2014 vide reference second cited. It was ordered interalia, that the public works upto a total cost not exceeding Rs.75 lakh can be entrusted with District Nirmithi Kendras without any bidding process.

2) Government received representations from several District Collectors for reconsideration of the monetary ceiling fixed for District Nirmithi Kendras stating that this stipulation badly affects the smooth functioning of the District Nirmithi Kendras which are currently executing individual works above Rs.75 lakhs. Honourable Minister for Revenue vide reference 3<sup>rd</sup> cited has also requested reconsideration of the above stipulation.

3) Government have examined these requests in detail and are pleased to enhance individual work ceiling fixed for execution of public works by District Nirmithi Kendras from the existing limit of Rs.75 lakhs to Rs.3 crores immediately.

4) The Government Order read 2 above stands modified to that extent.
