IFMS –Authorising Akshaya centres in the State to accept money for e-treasury-Approved –Orders issued.

ORDER

As per G.O. 1st read above, Government introduced e-treasury, an online treasury portal through which the public can make electronic remittances in favour of Government for various services/purposes. At present customers having bank account with net banking facility alone can make use of the service of e-treasury portal. Government vide G.O. read 2nd above permitted integration of nine more banks into e-treasury system along with three Agency banks. In order to widen the reach of e-treasury, it has been decided to authorize Akshaya centres also as collection points of Government money vide reference third cited.

Based on the foregoing, Government are pleased to authorize the Akshaya centres in the State to receive money on behalf of Government through e-treasury system. The Akshaya centres can accept Government receipts except those payments which require prior verification from the concerned office through e-treasury portal and transfer the equivalent money from their bank account to Government account. The rates of service charges payable to Akshaya centres for e-treasury transactions are fixed as follows:

Amount	Service charge
Rs. 0-1000	Rs. 10
Rs. 1001-5000	Rs. 20
Rs. 5001 and above	0.5% of the amount remitted

The detailed procedural formalities for the acceptance of money for e-treasury through Akshaya centres will be issued by the Government in IT department separately.

The rate of service charges for e-pay services, issued by IT department from time to time will be applicable for the service through e-treasury also.

Director of Treasuries shall take necessary action to facilitate this arrangement.
