**NOTIFICATION**

S. R. O. No. 205/2008.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Service Act, 1968 (19 of 1968) read with section 3 thereof, the Government of Kerala, hereby make the following rules further to amend the Kerala Service Rules, namely:—

**RULES**

1. *Short title and commencement.*—(1) These rules may be called the Kerala Service (Second Amendment) Rules, 2008.

(2) They shall be deemed to have come into force with effect from 1st day of April, 1983.

2. *Amendment of the Rules.*—In Part III of the Kerala Service Rules, in Appendix-X,—

- (a) in clause (ii) of Part D, after the words “with the application” the words and figures “as laid down in Rule 126 Part III Kerala Service Rules” shall be inserted;
- (b) in Form E, below the heading, for the words, letters and figures in brackets “vide G. O. (P) No. 386/83/Fin. dated 13-7-83” the words and letters “see clause (1) of Part D of Appendix-X” shall be substituted;
- (c) in Form E, in the last sentence, for the letters “N.B.” the word “Note” shall be substituted.

#### **Explanatory Note**

(This does not form part of the notification, but is intended to achieve its general purport.)

In the second report of the Committee on Subordinate Legislation (2001-2003) certain observations and recommendations with regard to the S.R.Os. issued during the year 1998 were made.
