ORDER

As per the Government Order read above, Government have extended House Building Advance by HUDCO to State Government Employees with certain terms and conditions. Sri.Abdul Manaf Konari, Office Assistant, Office of the Assistant Educational Officer, Tanur, Malappuram, vide letter referred to above has informed that as per Government Order cited, he has approached to HUDCO for additional House Building Advance but his application was rejected on the ground that the benefit will be granted to the employees working in TRIDA limits and hence he has requested the Government to issue a special order in this regard.

The terms and conditions of HUDCO at the time of launching the scheme the area of operation was stated as “ The proposed house/property for which the loan to be availed is to be located within the TRIDA limits” (within Thiruvananthapuram Municipal Corporation limits and 5 Panchayats namely Kalliyoor, Vilavoorkal, Vilappil, Pallichal and Venganoor)”. The above condition has not been included in the Government Order read above.

Government have examined the matter in detail and are pleased to include the following condition regarding area of operation as the 6th Point of Government Order cited:

“The proposed house/property for which the loan to be availed is to be located within the TRIDA limits” (within Thiruvananthapuram Municipal Corporation limits and 5 Panchayats namely Kalliyoor, Vilavoorkal, Vilappil, Pallichal and Venganoor)”.

The Government Order read as 1st paper above stands modified to the above extent.
