**ORDER**

As per Government Order 1<sup>st</sup> Cited, Government have reintroduced House Building Advance Scheme to Government Employees with an admissible amount of 50 times of basic pay subject to a maximum of Rs.10 lakh. As per reference 2<sup>nd</sup> cited Government have enhanced the maximum limit of House Building Advance to 20 lakh w.e.f. 01.04.2016.

2. It has come to the notice of Government that various applicants couldnot submit the application on time due to the unavailability of documents from various offices as the concerned officers were engaged with Election Duties.

3. Government have examined the matter in detail and are pleased to extend the date for the submission of application for the financial year 2016-17 as follows;

- Time for submission of applications in respective offices by Government Employees/ Teachers and furnishing the same to the Head of the Department - within 30.06.2016
- Time for furnishing of the Department wise eligibility list by Head of the Department to Finance Department - June 1- July 15

4. The applicants who have completed 5 years of service within May 1- 15 of 2016 will only be eligible for applying House Building Advance during this period.

5. The Government Orders and Circular above cited stands modified to this extend.


