### Abstract

Kerala Service Rules - 10<sup>th</sup> Pay Revision - Promotion from the post of Junior Superintendent (HG)/ equated categories to the post of Senior Superintendent/equated categories – Fixation of Pay – Option granted – Orders issued.

### ORDER

As per G.O(P)No.07/2016/Fin dated 20.01.2016 the scales of pay of State Government employees and teachers have been revised with effect from 01.07.2014 and the facility of option allowed for fixation of pay under Rule 28 A Part I Kerala Service Rules has been withdrawn with effect from 01.02.2016. Prior to the revision, Junior Superintendent(HG) on promotion to Senior Superintendent and similar promotions from ratio based scales of pay were given only an advance increment since the scale of pay of both the posts of common category is the same ie, 18740 – 33680. But in the Pay Revision, the scale of pay of Junior Superintendent (HG) has been revised to Rs.35700 – 75600, and that of Senior Superintendent to Rs.36600 – 79200. As it is a promotion from lower time scale of pay to higher time scale of pay, fixation of pay has to be done based on the option exercised by the officer under Rule 28 A Part I Kerala Service Rules. But the officers promoted from the post of Junior Superintendent(HG) to Senior Superintendent had not given any option at the time of their promotion since they were eligible only for an advance increment. But now they have to be given fixation based on their option under Rule 28 A Part I Kerala Service Rules. Option for fixation of pay under Rule 28 A Part I Kerala Service Rules has to be exercised by the officer within one month from the date of order of promotion or of taking charge in the promoted post whichever is later. But the time limit prescribed under the Rule cannot be followed in this case as the situation was changed due to Pay Revision.

2. Government have examined the matter in detail and are pleased to order that those who were promoted to the post of Senior Superintendent/ equated categories on Rs.36600 - 79200 from the post of Junior Superintendent (HG)/equated categories on Rs.35700 - 75600 during the period from 01.07.2014 to 31.01.2016 will be allowed to exercise option for fixation of pay under Rule 28 A Part I Kerala Service Rules in relaxation of the time limit prescribed under Rule 28 A Part I Kerala Service Rules. Such option will be exercised within a period of three months from the date of this order.
