**ORDER**

As per the Government Order read 1<sup>st</sup> above, Government have inter alia issued orders enhancing the existing rate of Dearness Relief payable to State Service Pensioners and Family Pensioners (whose pension/family pension has been revised as per G.O.(P) No.9/2016/Fin dt.20.01.2016) from 6% to 9% with effect from 01.01.2016.

In Para 10.1 of the Government Order read 2<sup>nd</sup> above, it is ordered that Ex-gratia pensioners/Ex-gratia Family pensioners shall be eligible for Dearness Relief. It has been brought to the notice of Government that the enhanced rate of Dearness Relief sanctioned vide Government Order read 1<sup>st</sup> above was not granted to Ex-gratia pensioners/Ex-gratia Family pensioners.

Government have examined the matter in detail and are pleased to order that the Ex-gratia pensioners/Ex-gratia family pensioners(whose pension/family pension has been revised as per G.O.(P) No.9/2016/Fin dated.20.01.2016) will also be eligible for enhanced Dearness Relief @ 3% with effect from 01.01.2016, as sanctioned to State Service Pensioners and Family Pensioners vide para 2 (x) of G.O read 1<sup>st</sup> above, subject to the conditions stipulated therein.


