ORDER

As per rules, Time Bound Higher Grade promotion will not be sanctioned to those who relinquished or relinquish regular promotion including ratio promotions. As per Rules in KER the post of Lower Division Clerk in Aided Schools shall be filled up by promotion of Attender, Peons, Sweeper and other Staff. Hence Government vide letter read above had informed that those Last Grade Employees in Aided Schools who relinquish further promotion as Clerk cannot be sanctioned Time Bound Higher Grade.

2. But several instances have come to the notice of Government where the Last Grade Employees of Aided Schools who relinquished promotion to the post of Lower Division Clerk continue in the same scale of pay throughout their service and will reach the maximum of the scale of pay within a few years. They have to retire from service without getting any further fixation benefits. However in Government Sector there is no such practice of denying the Time Bound Higher Grade promotion to Last Grade Servants who relinquished promotion to the post of Lower Division Clerk.

3. In the circumstances, Government have examined the matter in detail and are pleased to clarify that those Last Grade Employees in Aided Sector who relinquished promotion to the post

of Lower Division Clerk will be eligible for Time Bound Higher Grade in the entry post of Last Grade Servants as applicable to Last Grade Servants of Government Sector. As such the letter read first above stands cancelled.

This order will take effect from the date of issue.
