ORDER

As per the Government Order read as 1st paper above Administrative Sanction has been accorded for the release of an amount of Rs.10,69,41,333/- as 2nd instalment of Central Share and State share under NRLM/Aajeevika for the year 2015-16. Vide letter 2nd read above the Commissioner for Rural Development has reported that the expenditure was not incurred due to insufficient budget provision in the last financial year, hence requested sanction for the release of the amount from the current years budget provision. As per G.O read as 3rd paper above Administrative Sanction has been issued for an amount of Rs.4,96,83,333/- as 2nd instalment of Central and State share of General, SCP and TSP components under NRLM from the current years budget. An amount of Rs.5,72,58,000/- is re-appropriated for EAP component of NRLM, vide G.O. read 4th paper above.

2. Government after having examined the matter in detail, are pleased to accord Administrative Sanction and to authorise the Commissioner, Rural Development Department to release an amount of Rs.5,72,58,000/- (Rupees Five crore seventy two

Lakh and fifty eight Thousand only) to the Executive Director, Kudumbasree, Kerala being the 2nd instalment of Central Share under NRLM/Aajeevika (EAP Component) for the year 2015-16 from the current year budget provision as detailed below:-
