S. R. O. No. 747/2016.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules, further to amend the Kerala Service Rules, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Service (Fifth Amendment) Rules, 2016.

(2) They shall be deemed to have come into force on the 12th day of January, 2016.

2. *Amendment of the Rules.*—In Part I of Kerala Service Rules, after Rule 100, the following rule shall be inserted, namely:—

“100 A. Leave under rule 100 above may also be granted to female employees who are genetic mothers of children born on surrogacy from the date of delivery, on production of a medical certificate from the authorised Medical Officer.”

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G. O. (P) No. 2/2016/Fin. dated 12th January, 2016 the Government have granted the benefit of maternity leave to 180 days from the date of delivery, to the Female Government Employees, who are genetic mothers of children born on surrogacy, on production of Medical Certificate from an authorised Medical Officer. In order to give statutory validity to the said Government Order, Government have decided to amend the Kerala Service Rules.
