S. R. O. No. 748/2016.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules, further to amend the Kerala Service Rules, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Service (Sixth Amendment) Rules, 2016.

(2) They shall be deemed to have come into force on the 27th day of January, 2016.

2. *Amendment of the Rules.*—In Part I of the Kerala Service Rules, after Note 6 to rule 100, the following Note shall be inserted, namely:—

“*Note 7.*—Female officer transferred from one station to another within the same department while on maternity leave shall be allowed to avail the balance portion of the maternity leave from the next day of her joining duty in the new station subject to the conditions specified in note 6 above.”

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G. O. (P) No. 14/2016/Fin. dated 27th January, 2016 Government have ordered that a female officer on maternity leave who is transferred from one station to another within the same department will be allowed to avail the balance portion of the maternity leave from the next day of her joining duty in the new station subject to the conditions specified therein. Now Government have decided to give statutory validity to the said Government Order by suitable amendment to Part I, Kerala Service Rules.
