ORDER

Government of India have released an amount of **Rs. 43,98,75,000/-**(Rupees Forty three Crore Ninety eight Lakh and Seventy five Thousand only) to the State Government of Kerala as central assistance under Pradhan Mantri Gram Sadak Yojana(PMGSY) Scheme during 2016-17. The amount has to be released to Kerala State Rural Roads Development Agency vide sanction order read above.

2. Government after having examined the matter in detail, are pleased to authorise the Commissioner, Rural Development Department to release an amount of **Rs. 43,98,75,000/-**(Rupees Forty three Crore Ninety eight Lakh and Seventy five Thousand only) to KSRRDA being the Central share under Pradhan Mantri Gram Sadak Yojana(PMGSY) Scheme during 2016-17 as detailed below:

4. The Kerala State Rural Roads Development Agency, shall ensure that the fund released is utilized as per the conditions stipulated in the orders releasing funds by the Ministry of Rural Development, Government of India, read as 1st paper above.

5. This transfer of fund is exempted from all treasury restrictions.
