**ORDER**

The Accountant General has sought certain clarifications on the Government Order issued vide 4<sup>th</sup> read above for revising the re employment pay with effect from 01.07.2014. Accordingly, Government after examining the matter in detail and in superseding the G.O read 4<sup>th</sup> above are pleased to revise the re employment pay in respect of those who retired from service while drawing pay as per Pay Revision Order 2009 and were re-employed prior to 01.07.2014 and continued/continuing after the above date, in accordance with the principles laid down herein .

- i. Last pay drawn at the time of retirement including special pay if any
- ii. DA at 80% of Last pay (i.e.80 % of (i))
- iii. Fitment benefit at 18% of Last pay (i e. 18% of (i))

- iv. The sum of (i) to (iii) above ,as rounded off to the next higher stage / minimum of the corresponding revised scale whichever is applicable. The amount so arrived will be regarded as consolidated amount.
- v. After calculating the consolidated amount, the increment earned if any shall be added to that amount and the same will be treated as Revised Last Pay drawn.
- vi. The re employment pay shall be fixed by deducting the Revised Basic Pension from the Revised Last Pay drawn.

2.The following conditions shall be applicable in such cases ,

- (i) From 01.02.2016, they are eligible for DA on on re-employment pay and DR on pension .
- (ii) They are eligible for admissible DA on Revised Last Pay with effect from 01.07.2014 to 31.01.2016.
- (iii) They are also eligible for revised pension but are not entitled DR on pension with effect from 01.07.2014 to 31.01.2016 .
- (iv) They are also eligible for HRA and CCA applicable from time to time on the pay at the time of retirement and the rate admissible in their parent departments. It shall be calculated taking into consideration of the corresponding revised scale of pay of the post from which the pensioner retired.
- (v) The arrears of revision of pension ,if any,shall be paid as per para 9 of the order read 2<sup>nd</sup> above.
- (vi) The arrears of revision of re employment pay ,if any,shall be paid as per para 46 of the order read 1<sup>st</sup> above and the excess amount drawn if ary, shall be recovered from the first instalment of the arrears of revision of re employment pay. In the cases where the excess amount drawn exceeds the first instalment of arrears ,the balance amount shall be recovered from the very next instalment.
- (vii) If there occurs any grievances due to this revision, the same shall be taken up with Finance Department.

3. The revised re employment pay will be fixed by the Accountant General (A&E),Kerala in the case of Gazetted Officers and by the Drawing and Disbursing Officer concerned in the case of Non Gazetted officers. For this a form of undertaking as prescribed in G.O read 3<sup>rd</sup> above shall be furnished. The undertaking shall be

countersigned by the Drawing and Disbursing Officer in all cases and shall be forwarded to the Accountant General (A&E);Kerala in the case of Gazetted Officers.

4. In the case of employees who retired prior to any Pay Revision and re employed on or after 01.07.2014, their re employment pay shall be fixed as per G.O. read 6<sup>th</sup> above. The conditions laid down in the para 2 above is applicable to this category also.
