1. Applications are invited for the post of Chief Technical Examiner on deputation in the Finance (Inspection Wing -Technical) Department, Government of Kerala at Thiruvananthapuram from Officers of and above the rank of **Chief Engineer/Superintending Engineer (Civil) (in Central Govt./Central Govt. PSUs)** with scale of pay not less than PB-4-GP-8700/CPSU Scale of E6 (Of VI Pay Commission) and also from **retired Chief Engineers of Central Government/State Government, Central/State Government PSUs, retired Professors in Civil Engineering from Government Colleges on contract basis** for a period of 2 years extendable on basis of performance. Officers on an excellent track record with a Vigilance Clearance Certificate need only apply. Applicant should be Graduate/Post Graduate in Civil Engineering with atleast 20 years of post-qualification experience. Upper age limit for serving Superintending Engineers in Central Govt./Central PSUs is 58 years and 62 in the case of retired officers. There will be no upper age limit for serving Chief Engineers in Central Govt./Central PSUs. In the case of serving employees, deputation from organisations/départments not under the Administrative control of Governemnt of Kerala will only be considered.

2. The job involves furnishing technical advice to the Finance Department and inspection of works being executed by the Government Departments, such as, PWD, Irrigation, Harbour Engineering etc.

3. The selected serving candidate is eligible for the pay and allowances that he/she has been drawing from the parent department/Institution. For retired officers, a consolidated pay will be granted on the basis of the pay last drawn and Dearness Allowance. Adequate facilities will be provided and incentives for the work will be given, if found satisfactory.

4. Applications are to be submitted through proper channel along with Department NOC, ACRs & Vigilance Clearance. An advance copy of the application may be sent to the Joint Secretary, Finance (Administration) Department, Government Secretariat, Thiruvananthapuram on or before 20<sup>th</sup> June 2018.
