ORDER

In the Government Circular read above, guidelines were issued for the cross-mapping of heads of accounts in the Budget Allocation and Monitoring System (BAMS) for inter-CCO allotment.

2. Vide, the Government Order referred second above, the government have accorded sanction of ₹58,51,436/- under head of account '2515-00-102-38- takeover of Bhavanasree loans of Co-operative Banks' towards Kudumbasree for remitting the Bhavanasree loans taken from co-operative banks by the Kudumbasree Community Development Society. To disburse the amount to Kudumbasree authority, the original chief controlling officer of the above mentioned head of account, the secretary of Local Self Government Department (CCO-CODE-67DL) has requested to cross map the head of account '2515-00-102-38- takeover of Bhavanasree loans of Co-operative Banks' to the CCO viz., the Secretary, Urban Solid Waste Management Initiative (USWMI) (CCO Code-996A).

3. Government have examined the matter in detail and are pleased to accord sanction to cross map the heads of account, as detailed below;

4. The Secretary, Local Self Government Department and the Director of Treasuries shall take further necessary action on their part as required vide the Government Circular read above for cross-mapping the heads in BAMS to facilitate inter-CCO allotment via BAMS.
