The Central Board of Secondary Education, an autonomous organization under Ministry of Education, Govt. of India proposed to fill 01 post of Internal Auditor and Financial Advisor (IAFA) in Pay Level-13 of 7th CPC (PB-4 of Rs.37400-67000 + GP Rs.8700 of 6th CPC) on deputation basis (plus other admissible allowances as per rules of the CBSE).

The persons who fulfil the following eligibility conditions and willing to be considered may apply through proper channel:

(A) Officers belonging to Audit/Accounts/Finance Cadre/ Service/ posts in Central/State Govts/Union Territories/ Public Sector Under takings/ Autonomous Bodies/ Statutory Organisations:-

(i) Holding analogous post on regular basis;

OR

(ii) With 05 years' regular service in the Pay Level-12 of 7th CPC (Rs.78800-209200) or equivalent pay grade

OR

(iii) With 10 years' regular service in the Pay Level-11 of 7th CPC (Rs.67700-112100) or equivalent pay grade

AND

(B) Possessing experience of handling Administrative and Financial Budget/ Accounts/ Audit matter in a responsible capacity.
