ORDER

Sri. Anilkumar Chathoth was working as Computer Operator in Poverty Alleviation Unit, DRDA, Malappuram on daily wage basis with effect from 18.02.1999. He filed WP(C) No. 28816 of 2008 aggrieved by the rejection of his application for regularization in the post of Computer Operator in District Panchayat. Government vide order read as 2nd above, have regularized Sri. Anilkumar Chathoth in the post of Computer Operator under Principal Director, Local Self Government Department by creating a supernumerary post, which will cease to exist on his retirement, as a special case, in compliance with the direction of the Supreme Court in W.A No. 1747 of 2019 dated 13.07.2022. Consequent to the appointment of Sri. Anilkumar Chathoth, the Principal Director, Local Self Government Department, vide letter read as 3rd above has requested to fix the salary and other service conditions for the said post.

2) Government have examined the matter in detail and considering the fact that the sole reason for regularising Sri. Anilkumar Chathoth to the post of Computer Operator without considering the criteria for the appointment of that

particular post is for complying the order of Supreme Court. However, it is found necessary to include the post in the Pay Revision Order for the purpose of disbursing the salary and subsequent benefits to the incumbent. In these circumstances, Government are pleased to include the post of Computer Operator as 'Vanishing Category' just below the post of 'Auxiliary Nurse- cum –midwife' in the schedule of 'Panchayats' below Local Self Government Department in the Government Order read as 1st above, as follows:-

* The post of Computer Operator will cease to exist as and when the present incumbent leaves the post or retires from service.


3) The Government order read as 1st above stands modified to this extent.
