### **ORDER**

The XV<sup>th</sup> Finance Commission has recommended an amount of ₹390 crore consisting 40% as Untied Basic Grant and 60% as Tied Grant for ULB Non-Million Plus cities (All Municipalities except Malappuram) as XV Finance Commission Grant for the year 2024-25.

2) In order to ensure optimal and targeted utilization of XV FC Funds as directed by the Ministry of Housing & Urban Affairs, Government, vide order read as 3<sup>rd</sup> paper above, have modified the present system of withdrawal of XV Finance Commission Grants by the Local Governments. As per Government order read as 4<sup>th</sup> paper above, LGs were granted permission to open Bank account for operating XV FC Grant through PFMS platform

3) The Director, FCD vide, letter read as 5<sup>th</sup> paper above, has conveyed the release of 1<sup>st</sup> installment of untied Basic Grant amounting to ₹78.00 crore under XV Finance Commission Award to Non-Million Plus Cities for the year 2024-25 and requested to distribute the Grant on the basis of the recommendations of the latest State Finance Commission.

4) Government, after having examined the matter in detail, are pleased to issue the following orders:

- a) An amount of **₹78,00,00,000/- (Seventy-Eight crore only)** may be authorized to Urban Local Bodies (all Municipalities except Malappuram) and Cannanore Cantonment Board as 1<sup>st</sup> instalment of Untied Basic Grant under XV FC Grant for the FY 2024-25 as detailed below:

- b) US, Fin (Accts) is authorized to transfer credit an amount of Rs.8,46,500/- (Rupees Eight lakh Forty-Six thousand Five hundred only) to the Bank account of Cannanore Cantonment Board as detailed below:

- c) Untied Basic Grant can be used by the LGs for location-specific felt needs, except for salary and other establishment expenditure. Tied Grant can be used by the LGs for the basic services in equal proportion for (a) drinking water (including rain water harvesting and recycling) and (b) Solid Waste Management as recommended by XV FC and as per guideline issued by Government of India.
- d) This order shall be considered as an allotment letter.
- e) Director of Treasuries shall make available copies of this order to the Dist /Sub treasuries through Treasury intranet.
- f) The Secretaries of the Local Governments shall make necessary arrangements to transfer credit the amount to their respective PFMS accounts opened for XV FC Grant within 10 days from the date of issue of this order.






