ORDER

The Registrar, High Court of Kerala informed Government that as per the submission from the District Judge, Kasaragod, the LARR Authority, Kasaragod vide papers read 1st and 2nd paper above has ordered to convert an amount of Rs.2,13,04,375/- (Rupees Two Crores thirteen lakhs four thousand three hundred and seventy five only) and Rs. 1,41,28,590/- (One Crore forty one lakhs twenty eight thousand five hundred and ninety only) respectively, lying in the CCD Account of that honourable court to fixed deposits for a period of one year in a nationalised bank. It is reported that for effectuating the above order there is no bank account in the name of LARR Authority, Kasaragod. The Registrar (District Judiciary), High Court of Kerala has requested to accord permission for opening of a bank account in the name of Judge, Land Acquisition, Rehabilitation and Resettlement Authority, Kasaragod, for the above purpose..

Government have examined the matter in detail and are pleased to accord sanction for opening a bank account in the name of Judge, Land Acquisition, Rehabilitation and Resettlement Authority, Kasaragod, for converting Rs.2,13,04,375/- (Rupees Two Crores thirteen lakhs four thousand three hundred and seventy five only) and Rs. 1,41,28,590/- (One Crore forty one lakhs twenty eight thousand five hundred and ninety only) respectively, lying in the CCD Account of the honourable court to fixed deposits for a period of one year in a nationalised bank. This account is permitted for this limited purpose

only and subject to the condition that no Government funds are deposited or operated through this account.
